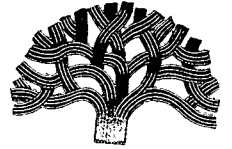

**RE: CONTINUATION OF CITY/SOCIETY AGREEMENT**


Dear Dr. Parrot:






